#### Introduction

The Edo State governorship elections conducted on 19 September 2020 led to the victory of incumbent Governor Godwin Obaseki of the People's Democratic Party (PDP). Some highpoints of the election were the low level of violence in contrast to the tense pre-election environment, the use of an online portal to transmit election results to the public, and the high level of citizen involvement across the country, as evidenced by the hashtag #EDODECIDES2020 which was trending on social media throughout the elections.

The Edo election was also one of the first elections to be conducted during the coronavirus pandemic in Nigeria, which makes it a useful case study for the conduct of elections during emergencies. While there was poor enforcement of COVID-19 protocols on election day, the pandemic also had positive effects in the sense that it forced some innovations such as the use of a virtual situation room by the Independent National Electoral Commission (INEC) to monitor the elections and respond to queries.

In order to further deepen understanding about the Edo elections and the factors that contributed to its success, this database has been compiled by the Electoral Hub, an organ of the Initiative for Research, Innovation and Advocacy in Development. It includes summaries of reports from civil society organisation (CSOs) as well as the media, which can be used by researchers, CSOs, other election practitioners, and the general public. It is hoped that the information provided in this database will facilitate further research and solutions to improve the integrity and credibility of our electoral process in Nigeria.

A lot of the tension is being generated by intra party struggles for the control of key structures ahead of the election     </li> <li>The fallout between Oshiomhole and his erstwhile political godson and incumbent governor, Godwin Obaseki has cast the election as a personal political supremacy battle between the godfather and his dissenting godson. Shortly before the dissolution of the APC National Working Committee, which he led, Oshiomhole allegedly influenced the Edo State Governorship Primary Screening Committee to disqualify Governor Obaseki from contesting on the APC governorship ticket. The political disagreement between Oshiomhole and Governor Obaseki came to a head with the disqualification of the latter from contesting in the party's primary election on 12 June. Governor Obaseki reacted to his disqualification by defecting, along with his deputy, to the PDP a week later.</li> <li>It is not only the APC that has had its internal squabbles or defections. The APC candidate, Osagie Ize-Iyamu, contested for the</li> </ul>

2016 Edo State governorship election on the platform of the PDP. In his explanation of the reasons for his decision to return to the APC, Ize-Iyamu stated that the PDP had been in disarray, a situation he claimed made it necessary for him to "return home" by re-joining the APC. In terms of geo-political origins within the state, both Obaseki and Ize-Ivamu are from Edo-South Senatorial districts and both candidates picked their running mate from Edo North Senatorial District, leaving Edo Central, as a key battleground for votes. A fight over who controls of the Edo State House of Assembly, which has been an ongoing battle since the 2019 general elections has also heightened tensions. On 17 June 2019, the Edo State House of Assembly was controversially inaugurated with only 10 out of the 24 members inaugurated. Those sitting and making laws for the state were said to be loyal to Obaseki while the remaining 14 legislators who remain loyal to former National Chairman, Oshiomhole were excluded from the legislative process. On August 3, there was a crack in the ranks of the pro-Obaseki lawmakers when Yekini Idiaye, deputy speaker in the pro-Obaseki legislative camp and two other previously pro-Obaseki legislators declared support for the governorship bid of Ize-Iyamu. This raised the number of legislators in the pro-Oshiomhole-Ize-Iyamy camp to 17. Idiaye was subsequently mpeached by six lawmakers in the pro-Obaseki House for his actions. CDD observers report that instead of issue-based campaigning the political parties and their candidates have largely focused their messaging around praising their preferred candidate, while impugning the character of the opposing party candidate. Since the start of the campaign there has been rampant defacing or outright destruction of campaign billboards. CDD has observed several instances the use of government vehicles for

the purpose of campaigning. This is in flagrant disregard for the

		<ul> <li>APC supporters have also reported to our observers that they are being coerced to withdraw their support for their preferred candidates through threats to revoke long held land allocations.</li> <li>CDD observers have found candidates and key figures of the two major parties have been using a lot of hate speech and derogatory and intemperate language during the campaign so far.</li> <li>As party candidates and key party figures deploy violent and charged rhetoric capable of inciting supporters, CDD observers have reported that their foot soldiers across the state, especially in rural communities, have also been exchanging verbal abuses, hate songs and chants, capable of provoking violent confrontation at a localised level.</li> <li>This sort of divisive language was the trigger for the 25 July clash between supporters of the APC and PDP in Kings Square in Benin, the Edo State capital. Clashes occurred after party supporters sang abusive songs to insult their perceived political adversary during a courtesy visit by Obaseki to the palace of the Oba of Benin. Reprisal chants and then a free for all fight between the two partisan camps then followed.</li> <li>The two leading political parties have established platforms to spread false news and disinformation on social media. The tension in the electoral space in Edo State is being fuelled by this weaponisation of fake news and disinformation online.</li> </ul>

	https://www.vanguardngr.com/2020/08/edo-election-campaign-turns-to-smear-war/	<ul> <li>The ongoing Edo State governorship election campaign which has already been adjudged as the dirtiest in the history of the state, this week, took a further dip into muddy waters with the smear campaign extending to the election regulatory body.</li> <li>The attack on the Independent National Electoral Commission, INEC came by way of salvos on one of the probable officials that could be deployed by the commission to preside over the election.</li> <li>The smear campaign opened on Monday with the PDP bringing to the public the quiet apology by the APC over the claim the previous week that Pastor Osagie-Ize Iyamu, the APC candidate had been endorsed by the Benin Chamber of Commerce, Industry, Mines and Agriculture (BENCCIMA).</li> <li>The APC campaign had been forced on Sunday, to issue a quiet apology in which it blamed a low-ranking campaign staff for misconstruing the chamber's interaction with Ize-Iyamu into an endorsement.</li> <li>Crusoe Osagie, Governor Godwin Obaseki's spokesman in a statement on Monday urged other groups whose names have been used by the APC to conjure endorsements that were never given, in the party's desperate bid to market and re-brand their gubernatorial candidate who is heavily burdened with credibility crisis, to speak up.</li> <li>The APC retorted sharply on Wednesday when it brought the issue of the missing Edo State commissioner for arts and culture, Osaze Ero-Osemwingie as its main bullet. Ero-Osemwingie, the commissioner for arts and culture has been out of the country since last year having reportedly been apprehended in a European country over alleged transgressions.</li> <li>The party made this challenge on Wednesday following what it described as the Governor's quiet replacement of the Commissioner with the swearing-in of Mr. Lawrence Ogieva as the new Commissioner for Arts, Culture, and Diaspora Affairs. He also questioned the governor's silence on the issue. In his response, Obaseki speaking through Osagie accused the APC of</li> </ul>

- running out of steam and resorting to cheap blackmail and falsehoods in its bid to remain relevant in the ongoing electioneering campaigns.

  The two sides have also fought over the outstanding court cases
- The two sides have also fought over the outstanding court cases involving one another. The PDP had through its publicity secretary, Chris Nehikhare raised the alarm on the alleged plot by the APC to move court cases involving one another out of Edo State to Abuja. When later in the week the Chief Judge of the Federal High Court sanctioned the move, the APC remonstrated with the PDP saying: "It is on record that the PDP for many months now have been boasting that they will use the Court to subvert the will of the People. They know their candidate is not popular and has no single chance of winning the election, hence the only alternative is to get the mandate through the back door, reenacting the Bayelsa State travesty." While the two candidates and their proxies have been turning on one another, the PDP campaign chief, Chief Dan Orbih has also not relented in his attacks on Comrade Adams Oshiomhole who he has repeatedly dubbed as the godfather of the APC candidate, Ize-Iyamu.
- His campaign weapon has been to use Oshiomhole's wounding words of 2016. Speaking at Ugbegun in Esan West Local Government Area on Monday, Orbih salvaged Oshiomhole as double mouthed saying: "He also told us that the pastor is not fit to rule this state; he also told us that he cannot be trusted with public funds. "To me, all what he said about his candidate has not changed. How can he make a u-turn and start telling Edo people to vote for that same man?
- On Thursday, the smear campaign extended to former civil rights activist and Resident Electoral Commissioner for Akwa Ibom State after the APC campaign accused him of a secret dalliance with Governor Obaseki. The APC in a statement issued by Mayaki alleged that Mike Igini met with Obaseki in the governor's private residence where a deal to rig the election was allegedly plotted. Igini in a swift response made available to Saturday Vanguard denied the report saying he passed through Edo State to Delta State for a funeral ceremony.

With that, the stage was set for the political battle for the soul of Edo State among the parties and the candidates.</li> <li>Going by the current voters' registers in the state, a little less than two million eligible voters are expected to file out next month to decide who will govern the state after November 12, 2020, when the current four year term of Governor Godwin Obaseki will end. But not a few observers of the politics of the state have given the election away as a straight contest between the two frontline political parties, the All Progressives Congress (APC) and the Peoples Democratic Party (PDP). While Governor Godwin Obaseki is the candidate of the PDP, Pastor Osagie Ize-Iyamu is running on the platform of the APC.</li> <li>This position is based, among other factors, on the results of past elections held in the state since 2007. Also, since the commencement of campaigns, the candidates of the two political parties have been the most visible, dominating the political scenes across the state while the presence of the other 12 other political parties and their candidates is barely felt as the day of the election draws nearer. The media space has been taken up by these two candidates and their political parties.
